LONG TITLE

A Statute to provide for the rules by which certain buildings and institutions are to be made extra-parochial.

The Synod of the Diocese of North West Australia resolves as follows.

Chapter 1 – Preliminary

NAME

This is the Extra-Parochial Statute 1961.

Chapter 2 – Scope of the Statute

- 1. The Diocesan Council may from time to time declare by resolution that any school other than a State or parochial school, any hospital, benevolent asylum, prison or any other public or charitable institution whatsoever, or cemetery which may be situated within any parish or parochial district shall be excluded there from and shall be extra-parochial and thereupon the buildings or institution or cemetery referred to in such resolutions shall be deemed to be outside the limits of any parish or parochial district; provided that no such building or institution shall be excluded from any parish or parochial district unless or until the clergyman in charge and, in the case of a parish or parochial district, the Churchwardens thereof have been notified in writing of the proposal to take such action and shall have been invited to express their opinion on the proposed exclusion; provided further that the Diocesan Council may from time to time by resolution declare that any such building institution or cemetery shall cease to be extra-parochial.
- 2. The Bishop may from time to time appoint during his pleasure a Clerk in Holy Orders to the office of Chaplain to any of such buildings or institutions.

Chapter 3 – Regulations & Related Legislation

REGULATIONS

Regulation making power

The Diocesan Council may from time to time make, amend or repeal regulations (e.g. policies and procedures) not inconsistent with the provisions of this Statute providing for records arising out of or incidental to the operation of this Statute and for all or any of the purposes, whether general or to meet particular cases, which may be convenient for the administration of this Ordinance or which may be necessary or expedient to carry out the overriding purposes of this Statute.

Review

The Diocesan Council will review the operation of this Statute on or before six years after its commencement.
