

THE ASSENT TO THE CONSTITUTION OF THE CHURCH OF ENGLAND IN AUSTRALIA, 1961

WHEREAS the General Synod of the Church of England in Australia and Tasmania at its meeting in Sydney on the 6th day of October 1955 approved of a Constitution to be known as "The Constitution of the Church of England in Australia" for submission to the Dioceses of Australia and Tasmania

AND WHEREAS it is deemed desirable to assent to the said Constitution

BE IT THEREFORE resolved by the Bishop Clergy and Laity of the Diocese of North West Australia in Synod assembled:

1. The Constitution of the Church of England in Australia approved by General Synod held in Sydney on the 6th. day of October 1955 is assented to by this Synod;
2. This Statute may be cited as "The Assent to the Constitution of the Church of England in Australia, 1961".

THE ANGLICAN CHURCH OF AUSTRALIA CANON OF 1966' ASSENT STATUTE 1968

WHEREAS the General Synod of the Church of England in Australia at its meeting in Sydney in September 1966 assented to a Canon to be cited as 'The Anglican Church of Australia Canon of 1966' subject to all Dioceses in the Church of England in Australia assenting thereto

AND WHEREAS it is considered desirable that the Synod of the Diocese of North West Australia shall assent to the said Canon

BE IT RESOLVED by the Bishop, Clergy and Laity of the Diocese of North West Australia in Synod assembled that:

1. This Synod assent to 'The Anglican Church of Australia Canon of 1966'.
2. This Statute may be cited as "The Anglican Church of Australia Canon of 1966" Assent Statute 1968".

AUSTRALIAN PRAYER BOOK STATUTE

1978

BE IT ENACTED by the Synod of the Diocese of North West Australia as follows:

SHORT TITLE

1. This Statute may be cited as the "Australian Prayer Book Statute 1978".

INTERPRETATION

2. In this Statute unless the contrary intention appears:

"Australian Prayer Book" has the same meaning as it has in the Australian Prayer Book Canon 1977;

"Australian Prayer Book Canon 1977" means the Canon passed by the General Synod of this Church, identified in the schedule hereto.

"Bishop" means the Bishop of North West Australia or the person administering the Diocese during the absence of the Bishop of North West Australia or a vacancy in the office of the Bishop of the Diocese;

"Diocese" means the Diocese of North West Australia;

"Parish" includes a Centre;

"Church building" means a structure as defined in the Parochial Statute 1970-1994;

"Church member" means a member as defined in the Parochial Statute 1970-1994;

"this Church" means the Anglican Church of Australia.

ADOPTION OF AUSTRALIAN PRAYER BOOK CANON

3. 3. The Australian Prayer Book Canon 1977 is hereby adopted.

USE OF AN AUSTRALIAN PRAYER BOOK IN PARISHES

- 4.

- (1) An Australian Prayer Book may be used at services conducted in a Church building as Parish services if, and only if, the priest of the Parish and a majority of the Church members duly convened for the purpose, have approved the use of An Australian Prayer Book by the Parish.

- (2) For the purposes of sub-section (1), a general meeting of the Church members of a Parish shall be convened and conducted in accordance with the provisions of the Parochial Statute 1970-1994.

USE OF AN AUSTRALIAN PRAYER BOOK AT OTHER PUBLIC SERVICES

5. An Australian Prayer Book may be used at services (not being services referred to in Section 4) conducted in the Diocese as public services of this Church if, and only if, the Bishop of the Diocese has approved the use of An Australian Prayer Book at the services.

OTHER USES OF AN AUSTRALIAN PRAYER BOOK

6. Except as provided in Sections 4 and 5, the use of An Australian Prayer Book in the Diocese is not subject to any restrictions.

BE IT RESOLVED by the Bishop, Clergy and Laity of the Diocese of North West Australia in Synod assembled:

1. That this Synod adopt the Canons identified in the Schedule hereto.
2. That this Statute be cited as "Canons of the General Synod of the Anglican Church of Australia 1981, 1985, 1987, Assent Statute 1988, Amendment Statute 1990".

THE SCHEDULE

Canon No 1, 1981. A Canon to Alter the Constitution of the Anglican Church of Australia with respect to the ordination of women.

Canon No 13(P), 1981. A Canon to regulate the practice and procedure of this Church with respect to the Marriage of Divorced Persons.

Canon No 15, 1981. A Canon concerning Canon 99 of the Canons Ecclesiastical made in the year 1603 and the prohibition of the solemnisation of matrimony between persons within certain prohibited relationships.

Canon No 17, 1981. A Canon to Amend the Appellate Tribunal Canon 1981 by inserting therein a Schedule.

Canon No 1, 1985. A Canon to authorise the use of a service for the reception into communicant membership of this church of baptised persons who were formerly communicant members of other churches.

Canon No 2, 1985. A Canon to ratify the amendment and consolidation of the Constitution of the Province of Western Australia.

Canon No 6, 1985. A Canon for the admission of children to Holy Communion.

Canon No 7, 1985. A Canon to regulate the practice and procedure of this Church with respect to the marriage of divorced persons.

Canon No 9, 1985. A Canon to amend the Long Service Leave Canon 1966-1973.

Canon No 12, 1985. A Canon to alter the Constitution to amend the definition of "member".

Canon No 14, 1985. A Canon to alter the provisions governing the Australian Clergy Provident Fund.

Canon No 16, 1985. A Canon to authorise the use of a form of service for the ordination of deacons.

Canon No 17, 1985. A Canon to authorise the use of certain alternative tables of lessons.

Canon No 18, 1985. A Canon to provide for the ordination of women to the office of deacon and for other purposes.

Canon No 22, 1985. A Canon to alter the Constitution in relation to deacons and the Houses of Synod.

Canon No 1, 1987. A Canon to alter the Constitution with respect to alteration of the Constitution.

Canon No 2, 1987. A Canon to amend the Long Service Leave Canon 1966-1985.

Canon No 5, 1989. A Canon to alter the Constitution in relation to the making of Canons.

Canon No 6, 1989. A Canon to alter the Constitution with respect to the title of a Primate who is not a Metropolitan.

WHEREAS this Diocese is a participating Diocese under the Long Service Leave Canon 1966-1987 of General Synod

AND WHEREAS General Synod has passed the Long Service Leave Canon 1992 which will only come into effect when all participating Dioceses have adopted it

AND WHEREAS it is desirable for this Diocese to adopt the 1992 Canon

BE IT THEREFORE RESOLVED by the Bishop, Clergy and Laity of the Diocese of North West Australia in Synod assembled:

1. This Synod adopts Canon No 8, 1992 the Long Service Leave Canon 1992 of General Synod.
2. The Long Service Leave Canon 1966-1987 of General Synod shall cease to have force in the Diocese on the day on which the Long Service Leave Canon 1992 comes into operation.
3. This Statute may be cited as "Canon No 8, 1992 the Long Service Leave Canon 1992 of General Synod Adoption Statute 1992.
